In *Confronting Postmaternal Thinking: Feminism, Memory, Care* (2011) Stephens identifies a significant cultural anxiety about caregiving, nurturing and human dependency she calls 'postmaternal' thinking. Stephens argues that maternal forms of care have been rejected in the public sphere and marginalised to the private domain through an elaborate process of cultural forgetting, in turn contributing to the current dominance of a degendered form of feminism. This book argues that refiguring postmaternalism requires opening up the maternal beyond the category of mothers and the nuclear family. We argue that the memorializing of the maternal in feminist scholarship needs to reflect its diverse legacies in the analyses of black feminism, socialist feminism and ecofeminism in order to destabilise the association of the maternal with neoliberalism and the depoliticization of feminism.
